## **FREEZE ALARMS**

Frozen pipes create devastating damage and a lot of grief to residents who suffer from the havoc they can create. When water freezes in a pipe, it cracks the pipe. When the water thaws, that broken pipe pours water into the walls, floors. and wicks into cabinetry and furniture.

Our condo docs require us all to keep our thermostats at 65 degrees (or above) during cold weather months. In bitterly cold weather, 65 degrees in your unit may be only 35 degrees in the wall or attic. Over the years there have been a number of frozen pipe events so we know that sometimes the temperature in walls and attics has dropped below 32 degrees.

2008, So, in at the suggestion of our insurance broker, the board purchased and distributed battery alarms operated freeze (Reliance Model THP-203) to each unit owner. If you were here then, it's time to put the alarm (receiver) in a window with maximum public exposure and the transmitter on the wall below the window.

If the transmitter detects temperature below 40 degrees, a red light in the receiver will flash. Anyone observing the flashing red should alert light occupant or, if no one is at home, call the Springbrook number (610-0165) immediate action will be taken.

New owners should phone Ron at 610-0165 to receive a freeze alarm.

This program has saved us thousands of dollars in insurance premiums. The savings in grief and discomfort to would-be future victims of a frozen pipe is priceless!

### **CHRISTMAS DECORATIONS:**

Now that we all have "new" vinyl sided buildings, we can no longer attach nails, screws, or other hooks to the exterior walls or door frames to hang decorations. (Magnetic hooks work well on the glass of storm doors!)

When you take your tree down, please deposit it under the basketball hoop in the overflow parking lot by the clubhouse (not at the dumpsters). We will have them picked up and removed in mid January. Thanks!

### **CANDLE LIGHT:**

The National Fire Protection Association savs December is the peak month for candle fires - almost 13,000 annually! Most occur when burning candles are unattended. Thev remind us to keep candles away from flammable and combustible materials and decorations & never, ever leave burning candles unattended.
